MCCSS Meetings and Proposal

We have been in close contact with our MCCSS Young Parent Services colleagues and met recently with the Child Welfare Branch to discuss alignment between Ujima Project and child welfare reform (specifically the strategic pillar of community-based prevention services to enhance family wellbeing). With both groups, we have made explicit our goal of securing sustainable block funding to ensure the continuity of this initiative. Over the summer, we are finalizing an "Ujima 2.0" proposal/budget for MCCSS to continue to sustain our current 9 Hubs and potentially expand to additional sites. We have received indication that MCCSS is amenable to receiving a proposal in September after the budget funding envelopes have been finalized. As we have demonstrated with Ujima Project, we are stronger when we work together and as such, will be working on a **shared OAYPA proposal** rather than at an individual agency-level to secure continued Ujima funding.

OAYPA Policy Paper

We are working with researchers from Wilfred Laurier to finalize the OAYPA policy paper (expected final draft – late July). We will use this advocacy tool to influence policy direction regarding YPI services in Ontario. Thank you to those who participated in the provider survey and promoted the survey to your clients!

Funders Luncheon and Follow-up Meetings

We were invited to a funders luncheon in May hosted by current Ujima Project funder with representatives from 8 foundations to discuss our sector, the Ujima Project and goal of continued funding. Several foundations have shown interest in supporting our project and have secured two individual funder follow-up meetings to talk in more depth about the possibility of continued funding. The presentation was well-received, and we are optimistic about forming strategic partnerships that will provide financial support and enhance the reach and impact of our project. and have secured two individual funder follow-up meetings to talk in more depth about the possibility of continued funding.

Meeting with Minister of MCCSS

Rose of Sharon hosted a meeting last week between OAYPA and **Hon. Michael Parsa** (Minster of Children, Community and Social Services).
